The Afterlife Party – Paranormal Investigation Experience Terms & Conditions

By booking and participating in an Afterlife Paranormal Investigation Experience hosted by The Afterlife Party, you agree to the following Terms and Conditions:

1. Age Restrictions

- All participants must be **18 years or older**.
- Proof of age may be required at check-in.
- **Children under 18 are not permitted**, even when accompanied by an adult, due to the nature of this experience.

2. Health & Safety

- This event involves walking, standing for extended periods and visiting dark, uneven, or confined spaces.
- Participants must ensure they are physically capable of attending.
- This experience is **not recommended** for individuals with:
 - Heart conditions
 - Epilepsy
 - Severe anxiety
 - Pregnancy

You participate at your own risk. The Afterlife Party and associated venues are not liable for injury, loss, or damage sustained during the event.

3. Albany Convict Gaol Site Conditions

- Surfaces at the Albany Convict Gaol are **not always even**. Please take care and **always watch your step**.
- It is a **condition of entry** that all visitors:
 - Observe **all warning signs**, and
 - **Follow instructions** provided by Albany Convict Gaol staff and The Afterlife Party Paranormal staff at all times.
- Albany Convict Gaol accepts **no liability** for loss or damage of personal belongings while on the premises.
- **No shoes – no entry.**
- *The Afterlife Party* staff reserve the right to deny entry or remove any participant who is acting recklessly, appears intoxicated, is being a public nuisance, or fails to comply with staff directions or posted signage.

4. Spiritual Risk Acknowledgment and Activity

Communicating with the spirit world may carry **risks that are not fully understood**, including the possibility of **spiritual or energetic attachments**. While rare, these experiences can be unsettling. We

strongly encourage all participants to take their **own spiritual safety and protection** into consideration before and after the event, as this is a deeply personal matter. *The Afterlife Party is not responsible for any spiritual effects that may be experienced during or after the investigation.*

5. Paranormal Disclaimer

This is an **entertainment and investigative experience**. While we actively document paranormal activity and have captured unexplained phenomena, **no specific results or encounters are guaranteed**.

6. Conduct

- Alcohol, recreational drugs and disruptive behaviour are strictly prohibited.
- Respect must be shown toward fellow Participants, event staff, the location and any spirit entities.
- Any participant behaving inappropriately, dangerously or disrespectfully will be removed **without refund**.

7. Cancellations and Refunds

- All bookings are **non-refundable**, unless the event is cancelled by *The Afterlife Party*.
- On the rare circumstance where *The Afterlife Party* need to end the investigation experience short, due to receiving serious threats or anyone in the group is harmed.
- If you are unable to attend, contact us in advance. Rescheduling may be offered at our discretion and subject to availability.

8. Event Termination for Safety Reasons

In rare circumstances, **The Afterlife Party reserves the right to end the investigation experience early** if the team receives serious threats, or if **any participant is harmed or placed at risk**. The safety of our guests and crew is our highest priority. In such cases, **no refunds will be issued**, but efforts may be made to reschedule or offer partial credit at the discretion of The Afterlife Party.

9. Filming, Photography and Mobile Phones

- During the event may be recorded for use in *The Afterlife Party* YouTube series and/or promotional content.
- By attending, you consent to the **recording and use of your image, voice and likeness** in any media without compensation or additional consent.
- Mobile phones (and other electronic devices) aren't permitted during the event. Guests may turn them off and leave them in the office where they will be secured (locked room). Mobile phone use will be permitted in the mid-way break for photos.

10. Liability Waiver

By signing *The Afterlife Party Participants Consent and Acknowledgement Form*, you acknowledge the risks associated with paranormal investigations, including but not limited to physical injury, emotional distress or spiritual experiences.

You voluntarily release and hold harmless *The Afterlife Party*, its staff, contractors and the Albany Convict Gaol from all liability for any **injuries, losses, damage or claims** arising from your participation.
